Notes

1. Where more than one passport is issued on the same day (outside of commercial hours), a fee of DKK 2.355 will be charged for the first passport and DKK 1010 for the subsequent passports.
2. Where more than one passport is issued on the same day (on weekends and closing days), a fee of DKK 3.365 will be charged for the first passport and DKK 1010 for the subsequent passports.
3. Price per hour. The payment shall be charged for at least one hour. Each hour commenced shall be charged as a full hour.
4. In cases where the request of various documents or if various documents are arranged in one single note because of the request for tax refund, a one-time fee of DKK 200 will be charged.
5. No fee will be charged for applications regarding naturalization of children below the age of 18 if the parents – or one of them – are Danish by birth or naturalization.
6. The commercial services are object to a minimum invoice of fees charged individually. Please consult the commercial sector of the Embassy in Brasília or the General Consulate in São Paulo for this service.

The Embassy

For passport application services at the Embassy in Brasília, the payment of the fee can be done by cash at the Embassy or by an electronic bank slip (girokort). Please contact the Embassy and inform your name, CPF and e-mail to receive an electronic bank slip. The information can be sent to the Embassy's email: bsbamb@um.dk

The Embassy will only proceed with the service when the payment has been confirmed.

If the payment is made outside of Brazil, please contact the Embassy for bank information.

General Consulate in São Paulo

For passport application services at the General Consulate in São Paulo, the payment has to be done by cash or check at the Consulate.

The Danish Honorary Consulates in Brazil

On the Danish Honorary Consulates in Brazil, it is only possible to apply for emergency passport, passport for children under 12 years and passport extension of a valid passport. The payment has to be done directly to the Consulate.
